# Summer Camp General Terms and Conditions

## Sunshine Studios Worldwide Ltd Summer School 2014 is regulated by the following terms and conditions:

1. Sunshine Studios Worldwide Ltd Summer School will provide high standard dance lessons through their faculty of teachers to every participant of the event.
2. Sunshine Studios Worldwide Ltd Summer School keeps the right to change the faculty of teachers and activities of the event under the organiser's discretion and without notice.
3. There will be a member of Sunshine Studios Worldwide Ltd Summer School staff supervising with a disclosed Criminal Records Bureau check at the time of the event.
4. Sunshine Studios Worldwide Ltd Summer School will provide chaperones throughout the event and life-guards for the activities in the swimming pool. However participants will be allowed to spend time without chaperones within the grounds of the venue.
5. There will be at least one person with a 1st aid certificate available 24 hrs a day throughout the event.
6. Sunshine Studios Worldwide Ltd Summer School organises the event taking great care in the selection of third party service providers; however Sunshine Studios Worldwide Ltd Summer School cannot be held responsible for services provided for them such as: Transportation, accommodation, catering services, guided and unguided tour services and any other service related to the event not provided directly by Sunshine Studios Worldwide Ltd Summer School.
7. All participants under the age of 12 will need to be accompanied by an adult.
8. In order to book a place in the event, application forms and full payment must be made no later than the appointed deadline date.
9. In case of cancellation, an amount of £150 will be non-refundable from the full amount. This is held as a deposit.
10. Sunshine Studios Worldwide Ltd Summer School cannot allow a student to start the course without a signed application form and a terms and conditions document.
11. Spaces are subject to availability and Sunshine Studios Worldwide Ltd Summer School will not take responsibility for any flight or other travel expense lost due to spaces being unavailable. Therefore please be sure you have reserved a place with Sunshine Studios Worldwide Ltd Summer School before booking any form of travel.
12. Participants who have accommodation provided through Sunshine Dance Ltd. Will be supervised to and from the dance venue. Transport will be provided for the excursions.
13. Transport to and from the airport can be arranged but flight details must be given to us at least one week in advanced.
14. Deposits are not refundable under any circumstances. However if the remaining balance has been paid, this will be refunded where there are medical circumstances prohibiting the participant from attending the course and with notice given at least 2 weeks prior to the start of the course. A medical certificate will need to be provided.
15. Sunshine Studios Worldwide Ltd Summer School is unable to refund fees due to the cancellation of the event for circumstances outside of our control.
16. Applicants are advised to consider taking out insurance against withdrawal due to injury/illness or circumstances requiring medical treatment or hospitalisation; or due to personal or family reasons or any other such circumstance which might prevent then completing the course. Applicants with an existing injury attend the course at their own risk.
17. Due to the nature of our activity, Sunshine Studios Worldwide Ltd Summer School cannot take responsibility for any injury or personal illness during the event. Personal accident insurance and health insurance are the responsibility of the participant or their parents/legal guardians.
18. Sunshine Studios Worldwide Ltd Summer School cannot take responsibility for any missing, damaged or stolen personal belongings -including mobile phones- these are the responsibility of the participant.
19. Mobile phones must be switched off during all classes and activities.
20. No participant under 16 is allowed to leave the venue at any time, under any circumstance, without the previous knowledge of the organisers and the consent of their parents/legal guardians.
21. Participants 16 years and over are allowed to enter and exit the venue under their own personal responsibility outside the course hours; however it is required under Health and Safety regulations that they sign out and in on exiting and entering the premises. Participants must adhere to this clause.
22. Every participant must show an acceptable standard of behaviour and conduct or they will be asked to leave the course. Their fees would be forfeited.
23. Due to the nature of our activity, our faculty may need to give guidance to the students that would involve gentle physical contact.
24. Photographs or video may be taken for future promotional material. If you do not want your child to take part in this please inform Sunshine Studios Worldwide Ltd Summer School Organisers.
25. General Refund Policy  
We have a non refundable £200 deposit. But any cancelations within 48 hours of camp date are non refundable, as someone else may have missed out on a place. Package 2 with excursions have a £400 non refundable deposit within 2 weeks of camp, due to deposit for excursions being booked and paid for in advance.

## For all Students Under 16
